## **Mission**

To change the expectations of students, teachers and parents to include the idea that all high school graduates from Burleson will have the opportunity to attain higher education and to cultivate the economic development benefits of expanding the attainment of post-secondary degrees and career certifications.

# **Purpose**

To encourage graduating high school seniors to further their education in Burleson, thereby:

- Helping to create a better trained, educated and prepared local workforce;
- Enhancing the local economy by supporting a thriving center for higher education;
- Capitalizing on the link between higher education and economic development; and
- Helping to ease the transition from secondary to higher education for Burleson families.

#### Goal

To provide every high school graduate from Burleson the opportunity to attain post-secondary Education.

# **APPLICANT INFORMATION**

Information for those applying for the Burleson Opportunity Fund scholarship.

# Scholarship Eligibility

- 1. A Burleson ISD high school graduate, or
- 2. A Burleson resident graduating from:
  - a. A non-Burleson ISD public high school,
  - b. An accredited private school, or
  - c. An accredited home school program.
- 3. Enroll at Hill College the fall semester after graduating high school.
- 4. Maintain qualifying residency within the City of Burleson and/or Burleson ISD while enrolled at Hill College

# Scholarship Application

- To apply, students are required to submit an application to the Burleson Opportunity Fund. Applications
  can be submitted through the Burleson Opportunity Fund website at
  www.BurlesonOpportunityFund.org.
- The application is used to determine interest and eligibility for the scholarship. Scholarships are not awarded based on academic merit or financial need. To be considered, a complete application must be submitted on or before the due date.

# Communication with Applicant

- All communication will be via email using the email address that the applicant provided on their application.
- Applicant contact information must be kept valid and up-to-date.

# Terms of the Fund

- All deadlines must be met in order to maintain eligibility and to receive the Burleson Opportunity Fund scholarship.
- The Burleson Opportunity Fund provides tuition and fees for post-secondary education at Hill College.
   Funds are disbursed directly to Hill College from the Burleson Opportunity Fund after other scholarships, federal and/or state financial aid sources are exhausted.
- If a BOF scholarship recipient resigns and/or drops below part time, as of the 1st class day of the semester through the 12th class day (Census Date), the student will be responsible for any percentage of tuition and fees owed.

#### FIRST-YEAR RECIPIENT INFORMATION

Information for those who are recipients of the Burleson Opportunity Fund scholarship in their first year of post-secondary education at Hill College.

## **Scholarship Requirements**

Once students are notified that they will receive the scholarship, they must fulfill the following scholarship requirements:

- 1. Be admitted to and enrolled in Hill College (<a href="http://www.hillcollege.edu/">http://www.hillcollege.edu/</a>).
- 2. Complete and submit proof of the Free Application for Federal Student Aid (FAFSA) and enter the Hill College school code 003573. (<a href="http://www.fafsa.ed.gov/">http://www.fafsa.ed.gov/</a>). It is recommended that students complete the FAFSA by the Texas priority deadline.
  - Students must submit all documentation required.
- 3. Complete and submit proof of the Hill College Scholarship Application (https://hillcollege.academicworks.com/).
- 4. Submit all requested forms and documents to the appropriate person(s) by the required due date. This includes the BOF Acceptance/Release form.
- 5. Meet in person with a Hill College academic advisor/success coordinator to develop a degree plan and register for courses.
  - A minimum of six (6) semester credit hours (SCH) of enrollment will be required each term (fall and spring) with a maximum of sixteen (16) SCH.
  - Eligibility for scholarship ends once a student has accumulated 60 credit hours from Hill College.
  - Eligibility for scholarship ends two calendar years after high school graduation.
- Register for and attend traditional classroom/face to face classes at Hill College-Burleson Higher Education
  Center with the exception of: Classes only offered online / Classes offered hybrid (traditional
  classroom/face to face & online) / Programs not offered in Burleson.
- 7. Enroll in Learning Frameworks PSYC 1100 in their first semester.
- 8. Complete 8 hours of community service prior to the first day of each semester. (a portion of the hours for spring eligibility must come from assisting with the BOF breakfast).
- 9. Assist the BOF in promoting the program and mentoring future students.

#### **Earn Credit Policy**

Recipients must earn credit in all enrolled classes. Recipients are allowed to drop only one class per academic year during the time they are receiving the scholarship.

# **Communication with Recipient**

All communication will be via email using the email address that the applicant provided on their application. Applicant contact information must be kept valid and up-to-date.

### Terms of the Fund

- All deadlines must be met in order to maintain eligibility and to receive the Burleson Opportunity Fund scholarship.
- First-year students entering their second semester are required to have a cumulative grade point average of 2.0 to qualify for BOF scholarship funds.
- The Burleson Opportunity Fund provides tuition and fees for post-secondary education at Hill College. Funds are
  disbursed directly to Hill College from the Burleson Opportunity Fund after other scholarships, federal and/or state
  financial aid sources are exhausted.
- If a BOF scholarship recipient resigns and/or drops below part time, as of the 1st class day of the semester through the 12th class day (Census Date), the student will be responsible for any percentage of tuition and fees owed.

## **SECOND-YEAR RECIPIENT INFORMATION**

Information for those who are recipients of the Burleson Opportunity Fund scholarship in their second year of post-secondary education at Hill College.

# **Scholarship Requirements**

Once students are notified that they will receive the scholarship, they must fulfill the following scholarship requirements:

- 1. Be admitted to and enrolled in Hill College (<a href="http://www.hillcollege.edu/">http://www.hillcollege.edu/</a>).
- Complete and submit proof of the Free Application for Federal Student Aid (FAFSA) and enter the Hill College school code 003573. (<a href="http://www.fafsa.ed.gov/">http://www.fafsa.ed.gov/</a>). It is recommended that students complete the FAFSA by the Texas priority deadline.
  - Students must submit all documentation required.
- 3. Complete and submit proof of the Hill College Scholarship Application (https://hillcollege.academicworks.com/).
- 4. Submit all requested forms and documents to the appropriate person(s) by the required due date. This includes the BOF Acceptance/Release form.
- 5. Meet in person with a Hill College academic advisor/success coordinator to develop a degree plan and register for courses.
  - A minimum of six (6) semester credit hours (SCH) will be required each term (fall and spring) with a maximum of sixteen (16) SCH. Students will be allowed a total of sixty (60) SCH or a maximum of two (2) years, whichever is met first.
- 6. Register for and attend traditional classroom/face to face classes at Hill College-Burleson Higher Education Center with the exception of: Classes only offered online / Classes offered hybrid (traditional classroom/face to face & online) / Programs not offered in Burleson.
- 7. Complete 8 hours of community service prior to the first day of each semester (a portion of the hours for spring eligibility must come from assisting with the BOF breakfast).
- 8. Assist the BOF in promoting the program and mentoring future students.

## **Earn Credit Policy**

Recipients must earn credit in all enrolled classes. Recipients are allowed to drop only one class per academic year during the time they are receiving the scholarship.

## **Communication with Recipient**

All communication will be via email using the email address that the applicant provided on their application. Applicant contact information must be kept valid and up-to-date.

## Terms of the Fund

- All deadlines must be met in order to maintain eligibility and to receive the Burleson Opportunity Fund scholarship.
- Second-year students are required to have a minimum of 16 community service hours after their first year, a
  minimum cumulative grade point average of 2.5 after their first year, and have submitted their FAFSA to Hill
  College to qualify for BOF scholarship funds.
- The Burleson Opportunity Fund provides tuition and fees for post-secondary education at Hill College. Funds are
  disbursed directly to Hill College from the Burleson Opportunity Fund after other scholarships, federal and/or state
  financial aid sources are exhausted.
- If a BOF scholarship recipient resigns and/or drops below part time, as of the 1st class day of the semester through the 12th class day (Census Date), the student will be responsible for any percentage of tuition and fees owed.

Application Opens December 1
FAFSA Priority Deadline January 15
FAFSA for 2nd Years Due January 15
Application Due March 1

Lottery (if necessary) By first week in April

Recipients Notified Prior to Senior Awards Night

Awards Night Presentation May at your respective high school

Orientation August (date TBD each year – attendance required)

Community Service Log Due Prior to the first day of class each semester

Spring Eligibility Notification December 31

Recipients must complete Hill College fall registration by the last Thursday in June. Failure to do so may result in the loss of your BOF scholarship.
